



**A Special Edition of the CCHA Newsletter about the State of
the Historic Chatham County Courthouse and
the Chatham Historical Museum.**

By now you have probably already heard about the fire. Here are some pictures and an update on the state of the museum collection. Late Thursday afternoon, March 25, fire broke out in the courthouse in the circle in Pittsboro. Most of the roof and much of the building's interior were destroyed before the fire was contained. Built in 1881, the building has undergone several additions and renovations, and at the time of the fire the building was again under repair, covered with scaffolding so that the windows could be replaced and other parts renovated and repainted. Fire losses include the courtroom, judges' and other offices, belongings of employees and some court materials. Our Chatham Historical Museum was in the SW corner on the first floor where the least of the fire was. We did incur water and smoke damage, but nothing actually burned. The full extent of the damage to the museum collection is not completely known, although most items have now been recovered from the building and we're increasingly optimistic that many materials can be restored. Here's a short time line.

Sunday, March 7, 2010

The courthouse is covered in scaffolding for window replacement and the clock tower is wrapped in Tyvek while paint is scrapped and the wooden tower is repaired.



Thursday, March 25, about 5:00 p.m.

Flames have not yet broken through. Note that the circle is not yet cordoned off and people are standing very close to the building.

Friday, March 26, 2010

Hot spots continue to break out for the next couple of days and no one from CCHA is given access to the courthouse.



Sunday, March 28, 2010

The Pittsboro police and a salvage crew aided by CCHA volunteers, remove museum materials from the courthouse.

Here the Masonic Apron, undamaged, is carried out.



Monday morning, March 29, 2010.



Items are placed in a building for cleaning and sorting. Here a dirty, wet storage cabinet is moved into temporary storage for cleaning and safe-keeping.



Monday, March 29, 2010.
Soggy and smoky CCHA Journals that had been for sale.

With professional advice, wet books were wrapped in freezer paper, packed tightly in boxes and placed in a deep freeze.



Tuesday, March 30, 2010
Staff from the Cultural Resources Disaster Recovery Team come from Raleigh to assist and advise us about drying and repairing. Fans were brought in to aid air circulation in the work area. Inventory is being taken and some papers are ready to be reassembled.

Thursday, April 1, 2010

Good news! The Chatham County Board of Commissioners votes to put the wettest of our materials with theirs for record recovery. This is the approximately 75 books now on hold in a freezer. During the past week CCHA has helped the county as it gathers information for insurance companies by providing interior photographs as the courtroom was, drawings from previous renovations, wood and carpet samples and paint color chips.
