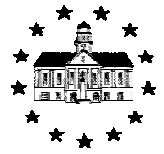

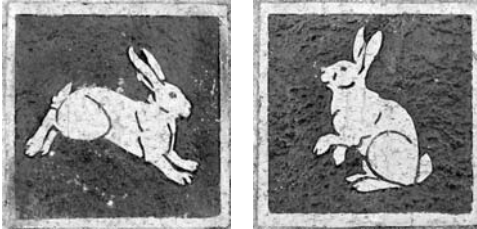

Old houses, aged country stores, church yards with intriguing gravestones, and venerable public buildings; settlements and cemeteries now lost due to dams and other

effects of progress; ordinary people who know the county's past and would love to tell you about it, as well as prominent civic leaders now long dead; all play roles in Fred Vatter's delightful saunter into some of the many corners of Chatham County's past.

Pittsboro's First Sunday and CCHA's Walk to Historical Places

The first Sunday of each month downtown Pittsboro is alive with activities such as exhibits, crafts and art vendors, music, food, drink, fun, friends as well as the Historic Courthouse Museum being open for visitors. On First Sunday of May, the 3rd from 1:00 to 4:00 pm CCHA will be hosting a walking tour of historic places around town. Docents will be available to tell of the history and answer questions at the sites. This is a leisurely tour at your own speed to the places you choose. You can begin at the Courthouse for a map and listing of places available for visiting; there will also be written cemetery material about some of the town's "historic residents." Please visit our website www.chathamhistory.org as time draws nearer to see a list of places that will be open. The walk is free and open to the public. Mix in some history with the street scene on a beautiful Spring day.

Did You Know...

Chatham County, North Carolina used to be one of the largest suppliers of rabbit meat to tables all across the nation. Rabbits were an important cash crop here.

New Exhibit at the Chatham Historical Museum

A new exhibit in the Chatham Historical Museum traces the history of schools in Chatham County from the private academies established in the 18th century, through the glory days of the union schools, to consolidation and integration in the late 1960s. In addition to a historical overview, on display are photographs, report cards and diplomas, school yearbooks, and principals' reports from as early as 1919. The museum, located in the historic county courthouse in Pittsboro, is open on Wednesdays from noon to 3:00PM and on the first Sunday of each month from 1:00PM to 4:00PM.

It's No Secret

CCHA, in cooperation with the staff at Wren Memorial Library, maintains two special collections. The family history collection is contained in 35 looseleaf binders alphabetized by family name, with limited cross-references to related families. These combine the files from Wren and Pittsboro Libraries and, if used with caution, can furnish valuable information to family history buffs. The second collection is contained in 25 looseleaf binders with newspaper clippings, brochures, and photocopied materials. Arranged by subject heads such as People, Industry, Churches, and Education, the files contain many photographs. A

computer dedicated to use in the area holds the searchable list of contents for the clippings collection as well as the index to the NC Genealogical Society's journal.

Also in the library's Local and Family History Collection are cataloged bound volumes of family history, reference books with a wide variety of information about Chatham County, how-to books on genealogy, and maps. A microfilm reader-printer and wireless internet access are also features. A display case, also maintained by CCHA, currently exhibits items that have been donated to the Chatham Historical Museum.

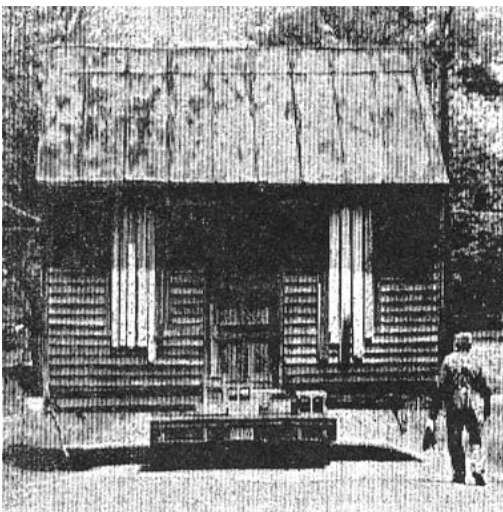

Hometown History 2009

The Federation of NC Historical Societies (FNCHS) will present their spring hands-on Hometown History Workshop at Central Carolina Community College on Wednesday, April 29, 2009 commencing at 9:30AM.

Given today's difficult economic situation, it is more important than ever for non-profit organizations to establish a strong staff of volunteers and to recruit new members to join.

During this practical workshop, Kay Mitchell-Thomas, tourism development officer for the NC Division of Tourism, Film, and Sports Development, and John Woodward, president of the Murfreesboro Historical Association, will share the secrets of recruiting and retaining volunteers. Jason Harpe, president of the Lincoln County Historical Association, will discuss how to recruit young people to join historical organizations and the different ways these new members can help your organization. He will also discuss how to use new technologies to appeal to Web-savvy generations.

This workshop will also be presented on May 13, 2009 at the Lincoln County Cultural Center in Lincolnton, NC. Registration for the session is \$15 for members and \$20 for non-members of FNCHS. Deadline for registration is one week prior to the date of the session.

The CCHA Chatham County Museum of history in the historic Chatham County Court House is open every Wednesday from 12:00PM to 3:00PM.

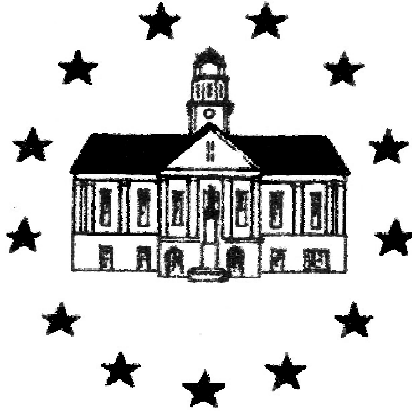
First Sundays

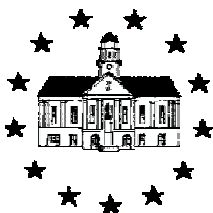
